

NCCP EVALUATION CHALLENGE – EXPERIENCED COACH

Gymnastics Canada provides an opportunity for experienced, previously trained gymnastics coaches living and working in Canada to ‘challenge’ evaluations, so that instead of taking the required courses and then completing the evaluation, the coach proceeds directly to the evaluation.

This respects and recognizes current coaching competence, which includes Canadian coaches with significant coaching experience or related background, and foreign coaches with approved training and certification. To pursue this recognition of coaching competence through Gymnastics Canada, coaches must successfully complete the evaluation process for the context in which they are coaching.

Coaches must apply for the opportunity to challenge an evaluation. They must be a resident of Canada and must be working in Canada. All applications must include a non-refundable \$75.00 Application Fee. If applying to be evaluated in more than one discipline in one application, the Application Fee is only paid once.

After Gymnastics Canada reviews the application, the coach and the club will receive written notification from Gymnastics Canada confirming the level of evaluation the coach is able to challenge. This will be completed on a case by case basis. Some considerations may be given to special cases.

When the level of evaluation is determined by Gymnastics Canada, the coach is then required to pay an Evaluation Fee in order to receive an evaluation package and the contact information of a Gymnastics Canada NCCP trained coach evaluator. Once the evaluation has been started, this fee is non-refundable. The specific Evaluation Fees are:

Gymnastics Foundations:	\$325.00
Competition 1:	\$350.00
Competition 2:	\$400.00

- Applications must be sent directly from the coach or club to Gymnastics Canada.
- Applications must be written, and must include:
 - ✓ Non-refundable Application Fee (\$75.00 payable to Gymnastics Canada)
 - ✓ A covering letter from the club in Canada that they are coaching at
 - ✓ An up to date resumé
 - ✓ A copy of the coach’s school/university transcripts (if applicable)
 - ✓ A copy of the coach’s coaching official certification or accreditation documentation from their country of origin (if applicable)
 - ✓ Official email from the coach’s Former National Gymnastics Governing Body, sent directly to coaching@gymcan.org that includes confirmation of coaching level, and a summary of the specific technical skills covered in all of the courses that make up your qualification
 - ✓ Contact information (name, email, phone number) from the coach’s former National Gymnastics Governing Body (if applicable)
 - ✓ Any other relevant information (FIG Brevet card, special honours received etc.)
- All documents must be officially translated, by a certified interpreter, to either English or French; copies of original and translated documents must be submitted.
- A minimum of 4 weeks is required to complete the application review process. If you have questions during this process, please send an email to Gymnastics Canada.
- A minimum of 4 weeks is required to complete the evaluation process.

HERE’S HOW TO APPLY!

You must apply for the opportunity to challenge a Gymnastics Canada evaluation. Your application must be approved by Gymnastics Canada, at which time we will contact you to confirm the level of evaluation you are able to challenge.

Please complete and submit the attached application form with all the required documentation (including the non-refundable \$75.00 Application Fee, payable to Gymnastics Canada).
